MEMBERSHIP RENEWALS Membership Renewals are the same as 2013. There are now three types of membership, Individual, Family and Junior. The family membership covers yourself, spouse and dependents - dependent has been clarified as under 18 at the time membership dues are paid. Dependents 18 and under must be with the adult member when using ranges. A family membership is \$150/year. The Individual membership just covers yourself although you can bring family or a guest out once a month. Senior discounts still apply. An Individual membership costs \$135. Members will be credited \$5/hour in JCOC tickets that can be applied to the dues for 2014. Up to 15 hours (4 hours for seniors) of participation credit at \$5/hr. can be applied to reduce the dues to \$60/yr. for members \$40/yr. for Seniors. In 2014 a non-participating family will pay \$150 while a family that participated at least 15 hours during 2012 will only pay \$75. Please note on your renewal if the renewal is for a "FAMILY" or "INDIVIDUAL" membership and pay the appropriate fee. REMEMBER TO GET AND SAVE YOUR JCOC WORK TICKETS. It is your responsibility to obtain these tickets from the committee chairperson for the event. Membership renewals are due by January 31st. You must complete the included Renewal Form.


