



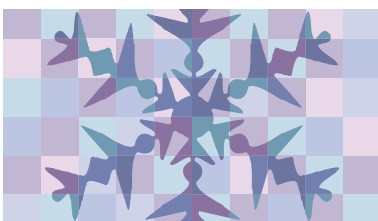

Reminder — Range use is from Sunrise to Sunset, No shooting after Sunset! No shooting on Sunday until noon.

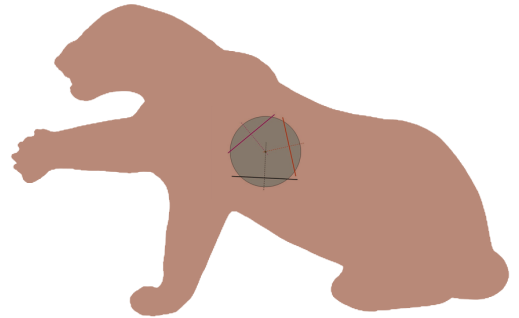
