Membership and Board Meeting Notes

The October Membership and Board meetings were held at the clubhouse on Tuesday, October 1st with 31 members present. The following actions were discussed and/or taken:



- 2 new members were approved.
- Trinity Lutheran School Outdoor Club was authorized use of the pistol range for one hour on 10/17 under the supervision of a JCOC member.
- Trap submitted \$995 for September shoots.
- Outdoor archery targets are being taken down for the winter months in the next several weeks. The JCOC S3DA kids are now beginning indoor shooting.
- \$1,200 was turned in for club rentals.
- Membership stands at 236 paid memberships with 352 adult members.
- Safety equipment has been installed at the waterfront area. Signage has been ordered and will be installed when received.
- Nominations were taken as outlined in the President's News.
- \$2,200 was authorized to Brooklyn Plumbing and Heating for the heat exchange replacement.
- The Board authorized an increase to \$200 for rental damage deposits from \$150.
- MUCC Region 7 was authorized to use the clubhouse for a rental on February 23, 2025 at no charge.
- \$700 was authorized for furnace service on 5 units.
- \$2,186.10 was authorized for two skids of trap birds for October delivery.
- Petty cash for director usage was authorized from \$50 to \$100.
- \$300 was authorized for lawn equipment season ending maintenance.



The new membership renewal/new member application for 2025 is on the JCOC website under the "Membership" tab. Renewing members may renew online and pay with credit card or PayPal by clicking on the yellow "Membership Renewal" tab in the upper right corner of that page and follow the instructions. You MUST have your membership ID number. If you renew using PayPal you "will receive" a Google document you "MUST" complete and return before you will receive your new membership card. The club must have the information requested on the Google document. You may also print and fill out the application from the website and mail with payment to the Club P.O. Box. Renewing members have until January 31st, 2025 to renew and use your earned work tickets. 2025 membership applications will be attached to the December newsletter.

Lost Membership card replacements will cost \$10 beginning January 1, 2025!


